RESOLUTION TO SET PUBLIC HEARING REGARDING THE REAR STUCTURE AT 15 CHURCH STREET

WHEREAS, the Village Board has been informed of a potentially unsafe structure located in the rear of 15 Church Street located within the Village; and

WHEREAS, the Building Inspector has determined that the condition of the rear structure ("Structure") is unsafe and in danger of collapse; and

WHEREAS, Village Board desires to afford the property owner an opportunity be heard with respect the recommendations of the Building Inspector to be received in final form by the Village Board.

NOW, THEREFORE, BE IT RESOLVED that:

Section 1. The above "WHEREAS" paragraphs are incorporated herein by reference.

Section 2. The Village Board hereby schedules a public hearing on September 25, 2024 at 6:00 p.m. or soon thereafter as can be heard to determines the appropriate action to be taken with respect to the unsafe Structure.

Section 3. The Village Clerk and Building Inspector are hereby directed to cause a Notice of Public Hearing and to proceed with all appropriate notifications and required publications of the Notice of Public Hearing as required by law and as recommended by legal counsel for the Village.

Section 4. The Village Mayor and any officer, employee or consultant of the Village as directed by the Village Mayor, is hereby authorized to take any and all actions necessary to carry out the provisions of this Resolution.

Section 5. This Resolution shall be effective immediately.

RESOLUTION TO SECURE AND RESTRICT ACCESS TO REAR STRUCTURE AT 15 CHURCH STREET

WHEREAS, the Village Board is aware of potentially unsafe conditions in and around the rear structure located at 15 Church Street within the Village which is noncompliant with the terms of Chapter 40 (Buildings, Unsafe) of the Village Code; and

WHEREAS, the structure is currently damaged and is at risk of structural collapse in its current state; and

WHEREAS, the Village Board desires to restrict access to the rear structure at 15 Church Street ("Structure") until further notice to ensure the safety of neighboring properties during investigations and fact-finding hearings to determine the safety of the property; and

WHEREAS, the Village Board desires to ensure the owners and occupants of 15 Church Street are afforded the full due process with respect to further proceedings concerning the Structure.

NOW, THEREFORE, BE IT RESOLVED that:

Section 1.	The above "WHEREAS"	paragraphs are incor	porated herein by reference.

Section 2. The Village Board hereby authorizes and orders that the Structure be secured and access restricted until a public hearing, a written finding of fact is determined and an order is issued based on that finding of fact with respect to the repair and/or demolition of the Structure.

Section 3. The Village Building Department and Police Department are authorized to take actions necessary to prevent access to the structure and ensure the security of the structure, including, but not limited to, posting signage on the building, locking the structure's doors, installing fencing or similar materials around the structure and preventing persons from accessing the structure or its immediate environs.

Section 4. The Village Mayor and any officer, employee or consultant of the Village as directed by the Village Mayor, is hereby authorized to take any and all actions necessary to carry out the provisions of this Resolution.

Section 5. This Resolution shall be effective immediately.
