MAYOR'S REPORT/ANNOUNCEMENTS

Each young artist described his or her square. The quilt was then presented to the Village Board. It will be on display at Village Hall and also at Centennial Events.

The Chief stated that they have been awarded a grant from DCJS. The grant is a \$200,000 technology grant. It will be used for enhancing current technology, adding new technology including as side scan SONAR, surveillance cameras, servers, tasers, and drones.

Chief Eirand also reported that while his department was assisting Parks and Grounds with prepping the beach for the season, Detective Dwyer and Sergeant Jones performed a water rescue of a woman and her dog who became distressed in the cold water. Those officers will be recognized at June's meeting.

Greenwood Lake PD hosted an Easter Egg Hunt and a Bike Rodeo. Both events were well-attended.

June 8, 2024, is the Chamber of Commerce Street Fair. The Police Department will be shutting down 17A between Vine Street and Chestnut Street for most of the day.

COMMISSION REPORTS

Trustee Kelm: Congratulations to the new School Members: Mike Emsworth, Patty Kaminsky, and John Thurber. The school budget also passed. Please visit the Greenwood Lake Public Library's website, <u>https://gwllibrary.org</u>, for a list of their available programs. The Senior Center hosts Zumba, yoga, and lunch once a month.

Trustee Sellier: This report covers Planning, Zoning, and Building for the month of April. The Building Department took in \$4,702 in April; fifty percent of that was for building permits. The Planning Board met in April. Benjamin's Steakhouse was on the agenda. Their traffic study was presented. The ZBA met in April; there were two applicants, both we variances which were granted. Trustee Sellier also attended the Warwick Cares event on May, 4, 2024, which was in support of May as Mental Health Month. He will be putting together a one-page information sheet for the public.

Trustee Trazino: He has been working with Chief Eirand on the technology grant which he received. He briefly discussed how this new technology will affect the Police Department and assist them in doing their job.

Attorney Report – Brian Nugent: No report except for the Klastow settlement, which he will discuss if needed.

Clerk's Report- Katheleen Holder: We are still collecting water bills; taxes will go out by the end of the month. We have also been working on fulfilling beach pass orders.

OLD BUSINESS

Golf Carts: Home Rule has been submitted which will allow the Village to make a law concerning the use of golf carts on village roads.

Hotel/Motel Tax: Home Rule has been submitted which will allow the Village to make a law implementing a local tax for hotels, motels, and short-term rentals.

Beach Passes: Passes purchased online will not be available for pickup at Village Hall for a few days. Passes can be picked up at the beach.

NEW BUSINESS

MS4 – The Village is working on stormwater mapping with our engineers. The MS4 report as well as an Emergency Action Plan is necessary and required by New York State.

DCJS Grant: Greenwood Lake Police Department was awarded a \$200,000 grant for technology. **Lake Treatment:** The Village received an analysis from Tigris (our lake management company) on a course of treatment. Letters have gone out to the public concerning the treatment. We are hoping to have it done by mid-June as to not disrupt the beach season. Senator Skoufis is also trying to secure a grant for the Village to purchase a new weed harvester.

PRIVILIGE OF THE FLOOR

Victor Ludmerer, 129 Edgemere Ave., expressed that he would like the Planning Board and ZBA to remain intact and not to be combined. The mayor responded that a law had already been passed and that there have been numerous public hearings on this matter. He also mentioned that over the past few months, Mr. Ludmerer's comment is the first he has heard regarding this local law.

Lisa Mulcahy, 138 Lake Street, asked about the hotel/motel tax. Mayor Howley responded that a law has not been passed regarding this and that Home Rule has been submitted to Albany which will allow the Village to make a law implementing a local tax for hotels, motels, and short-term rentals.

Diane Bramich, Rumsey Road, requested that the Water Department move the summer water valve be moved so that the plow does hit it. It is hit every year. She also added that she is against combining the ZBA and the Planning Board.

Marilyn Hayden, 4 Windermere Ave., asked if she can borrow the quilt for the Centennial Art Show on June 2, 2024. Also, there is a Jasper Cropsey talk on June 9, 2024.

Tatyana Federenko, 2 Wilson Street, said that she has seen golf carts driving on her street and questioned their legality. Mayor Howley and Attorney Nugent said that there are low speed vehicles which are registered and are allowed on the road. She also asked about using the water grant monies on the water lines. She also said that it is hard for people who cannot manage stairs to attend Village Board Meetings. Clerk Holder mentioned that we did just receive BAN monies to repair the elevator and trustee Kelm added that the Board will meet in Village Hall if they need to accommodate people who cannot manage the stairs.

Zack Sawaged, 641 Jersey Ave., is against the new hotel/motel tax. He feels people are taxed enough.
